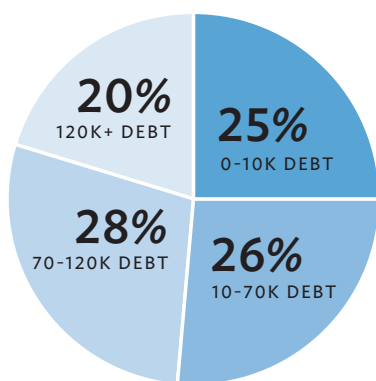




FUNDING PRIORITY:

SCHOLARSHIP GIFT LEVELS*

We offer two types of gift opportunities. Endowment gifts are invested to generate annual income in perpetuity; expendable gifts are used in their entirety each year.

Endowment**

Fellowship (including a full scholarship, research support and summer funding): \$1.25 million

Full out-of-state scholarship: \$1 million

Full in-state scholarship: \$500,000

Half in-state scholarship: \$250,000

Quarter in-state scholarship: \$100,000

Annual Expendable

Full out-of-state scholarship: \$44,000

Full in-state scholarship: \$24,000

Half in-state scholarship: \$12,000

Named expendable scholarship: starting at \$5,000
